**NUDO SPHYNX COMMITMENT:**

NuDo Sphynx provides a 72-hour limited warranty guarantee that the above cat is in good health at the time of purchase. SELLER also warrants that the kitten is free of the feline leukemia virus (FeLV), feline infectious peritonitis (FIP), and the feline immunodeficiency virus (FIV) at the time of purchase. BUYER must notify NuDo Sphynx of any claim under the warranty immediately. The cat may be returned to Nudo Sphynx (at buyer's expense) for a refund (minus shipping fees) or exchange for a new kitten (Nudo Sphynx's decision) if a licensed veterinarian documents a life-threatening illness. If a replacement is not available at the time of return, NuDo Sphynx will have up to one year to furnish a comparable replacement or provide a refund. The cat cannot be returned for compensation after the guaranteed period has expired and/or if the cat has been exposed to another cat in BUYER's home. NuDo Sphynx will not honor any health guarantee if the cat dies of a virus from contact with another animal. It is highly recommended that the above cat is quarantined during the 72-hour warranty period. Under NO circumstances is the cat allowed to be "destroyed" before notification and agreement with NuDo Sphynx. NuDo Sphynx is not responsible for illness, injury, or death caused by or during shipping.

If the cat above should die within two (2) years of age due to a congenital or hereditary defect, NuDo Sphynx will replace the cat with

another cat or provide a refund (NuDo Sphynx's decision), excluding shipping fees if applicable. NuDo Sphynx must receive proof of a defect in the form of a complete autopsy report completed by a licensed veterinarian, performed at BUYER's expense. NuDo Sphynx will make every attempt to replace the cat with a cat of similar quality in a timely manner but will have up to one year to do so. If buyer is choosing a cat older than 1 year and chooses not to test for HCM prior to pick up, NuDo Sphynx will not replace cat or give a refund for the cat.

NuDo Sphynx has completed all age-appropriate vaccinations, deworming, and medical examining necessary. Should BUYER choose to vaccinate for feline infectious peritonitis (FIP), ringworm, feline leukemia virus (FeLV), or feline immunodeficiency virus (FIV), this warranty is \*VOID\*. NuDo Sphynx will not warranty the kitten against any adverse reactions to future vaccinations.

#### **BUYER COMMITMENT:**

BUYER accepts the responsibility of caring for the above cat and will adequately provide for its welfare. BUYER agrees to keep the cat indoors at all times in a clean and pleasant environment, not caged, and with proper nutrition, health care (including yearly veterinarian checkups), companionship, and adequate space for exercise. Above cat should only be allowed outdoors while on a leash and while under close supervision. BUYER agrees to inform NuDo Sphynx of any health issues that arise in above cat's lifetime.

BUYER understands that if the cat is found to be neglected or mistreated in any way NuDo Sphynx has the unconditional right to reclaim the above cat without a refund of the purchase price. Neglect shall include but is not limited to: being left alone without human companionship for periods more than 72 hours, lack of proper sanitary facilities, being caged, providing poor diet, and poor health.

Mistreatment shall include but is not limited to: lack of proper food, lack of proper medical care, lack of fresh water, and any form of physical abuse. BUYER will be responsible for any veterinary bills directly incurred as a result of any neglect or mistreatment.

BUYER agrees not to declaw and understands that declawing is a mutilation involving the amputation of a large portion of the cat’s toes. BUYER agrees that under NO circumstances will above cat ever be sold, leased, or given to any pet shop, animal shelter, research laboratory, or similar facility.

Should BUYER not be able to keep the above cat for any reason, including the incapacitation or death of the BUYER, NuDo Sphynx has the right of first refusal and/or the option to assist in finding a suitable new home. This remains in effect for the entire life of the above cat.

Any legal action which may arise under the terms of this contract will be brought in San Antonio County, Texas, USA. BUYER shall be liable for any court costs and related charges including attorney’s fees associated with NuDo Sphynx enforcing the terms of this contract. In signing this document, BUYER acknowledges that he / she has read, fully understands, and agrees to all of the terms and conditions stated above. The laws of the State of Texas shall be controlling.
